

What is the 200 Club

The principle of the 200 club is that its members make a regular monthly payment by standing order and there is a regular monthly draw of which a percentage of 60% the income is given back to the members in first and second cash prizes each month. The remainder of the income is used to build up a fund for specific projects which will enable the AYC to improve facilities for its members. Its win-win for the 200 club members and the club.

How does it work

You purchase a share; each share costs £1.00 per month payable *in advance on standing order*, for each share purchased you will receive a unique number. You can purchase as many shares as you like. Your number or numbers are placed into a monthly draw which is held at management or social gatherings every month or bi-monthly.

Rules

- 1). Each share will cost £1.00 per month payable in advance by standing order or paying full year in advance.
- 2). Participation in the monthly draw is conditional on the shareholders being fully paid up.
- 3). The draw shall take place at the management meetings or social events every month or bi-monthly. The numbers are drawn by non members of the 200 club who are available on the day of the draw.
- 4). The number and value of the prizes may be varied but will always total at least 60% of the value of the shares currently held.

Become a Member of the 200 Club

Simple you complete a joining and standing order form these can be requested by sending email to club email address or downloaded from club website. State how many shares you wish to purchase each month. Example; one share will cost you £1.00 per month; two shares £2.00 per month, the more shares the better chance of winning. Once we have received the forms and standing order has been confirmed as set up by the club's treasurer then you will be issued
